Introduction

The Performance Manager 5.0.5 release delivers enhancements to the Document Sign-off feature, the ability to view employee enrollments while performing appraisals, and impersonation for clients with integrated Performance Manager and NetLearning solutions.

Appraisal reports have also received updates to provide more granular scoring data, and the online help system was overhauled to offer an improved interface and increased functionality.

System Requirements

The following system specifications are the recommended minimum requirements for using Performance Manager. HealthcareSource is constantly working to expand these minimum specifications to include additional systems and browsers to ensure our customers are able to access Performance Manager from a wide range of computer setups.

Browsers: Internet Explorer 8.0 (not in Compatibility Mode)


Internet Explorer 9.0 (not in Compatibility Mode)

Safari 5+ Chrome 16+ Firefox 10+

For security reasons, on shared machines you should ensure Internet Explorer is checking for a new version of the webpage with every visit. The *Every visit to the page* option should be checked under **Temporary Internet Files** settings (found on the **General** tab).




Under Trusted Sites, enter pfm.healthcaresource.com to ensure full functionality.





Under the **Privacy** setting you will have an option to adjust your **Pop-up Blocker Settings**. Make an allowance for *pfm.healthcaresource.com* by entering the web address in the field **Address of Web site to allow** and clicking **Add**.

The enhancements listed below for Performance Manager are controlled by system-wide permission settings. Not all users will have access to the functionality as described.


Enhancements – Integrations

Item 1: Enrollments on appraisals

Ref# 101360

For integrated clients, managers performing appraisals for employees are now able to view the number of learning enrollments yet to be completed by the employee directly from the appraisal page in Performance Manager. This allows managers to view enrollment information without having to navigate away from the appraisal.

A new notification area has been added under the standard toolbox on the right side of the appraisal page. This area displays the number of outstanding course/class enrollments for the employee. Clicking the notification opens the employee file window and displays the Learning tab, where additional details about the outstanding items can be reviewed.



Item 2: Impersonating in integrated solutions

Impersonation is now available for all clients with integrated Performance Manager and NetLearning solutions.

Users with necessary permissions to the Impersonation feature can view integrated pages while impersonating a user. This includes viewing learning opportunities, learning assignments, and reports.



Clients with integrated systems can continue to use the same Performance Manager URL they have today (https://pfm.healthcaresource.com/performance/login.aspx?c=clientname). The system automatically redirects to a new URL (http://login.healthcaresource.com/clientname/logon) to log in and access the integrated solution.

Note: Participating clients need to whitelist the new integrated URL.

Item 3: myCompetencies widget

The myCompetencies widget is now available in Performance Manager, allowing learners to access their assigned competencies.

The myCompeteices widget is found on the *Learning* page under the **My Folder** menu. This feature is available to clients who are integrated and have licensed NetCompetency functionality.


Item 1: Document sign-off notifications

Several new notifications have been added to Performance Manager to support the Document Sign-off feature delivered in the 5.0.4 release.

The Message Center page under Admin contains a new Documents category. The new notifications under this category include:

- Notification when Task Created
- Reminder on Task Due Date
- Reminder every date after Task
 Due Date
- Reminder # days before due
- Reminder # days after due





Item 2: Reporting on appraisal scores

Custom reports have been updated to include both section scores and averages for self, multi rater and manager appraisals.

Note: These fields only appear for appraisals completed from release day forward. Scores cannot be calculated retrospectively.


Item 3: User assistance


The online help system for Performance Manager has been updated to provide greater search functionality, compatibility with mobile devices, and a cleaner, more modern interface.

Benefits of the updated system include:

- Search available in header of every page
- Context-sensitive side menus displaying only related content



- Navigation bar with drop-down menus, similar to the navigation found in Performance Manager
- · Responsive design automatically reformats to device and/or screen size
- Provides more robust platform for delivering additional features as solutions evolve
